The on grounds RV space for 2008 includes space in Lot 16, the Ogden Pad, Lot 25, and the Amphitheater. All stock trucks will be assigned to Lot 16. RV spaces are \$550.00 payable in advance for the State Fair Season. The State Fair season is August 8th through September 7th, 2008. Spaces are full hook ups: water, sewer, and power. Credentials for vehicles other than your RV are \$150.00 each for the State Fair Season. If you are bringing any vehicle other than your RV, please include your payment with your RV space request.

To apply for a trailer space, please complete this application form and return it with your rental fee to the RV Office (make checks payable to: CAL EXPO)

1. Spaces will be allotted on a first-come, first-served basis. RV hook ups inside the fairgrounds are available for vendors, concessionaires, sponsors, and exhibitors only. If you are applying for more than one RV space, please note that on your application and fill in the information for all vehicles, or use a separate application for each RV.
2. **ALL APPLICATIONS AND PAYMENTS MUST BE RECEIVED PRIOR TO MOVE IN.**
3. Every effort will be made to accommodate your request for a particular lot or space. **However, spaces fill quickly and will be assigned on a first come, first serve basis.**
4. Failure of Tenant to vacate the premises within three days (72 hours) of receipt of written notice of termination of this agreement will result in the trailer being removed from the premises by State and stored at the nearest secured storage facility at State's discretion. Failure by State to act immediately upon expiration of the notice is not a waiver of any rights. Furthermore, until said vehicle is removed from the premises, Tenant will be charged rent and any cost or damages caused by or incident to Tenant's failure to vacate the premises, including attorney's fees, cost of removal of trailer to the storage facility and the cost of storage. State is entitled to a lien upon the trailer and contents therein for the charges due from the Tenant (Civil Code 799.39).

WELCOME TO CAL EXPO PARK RULES

We hope you have a pleasant stay at our facility. In order to make your stay and the stay of other RV'ers around you a happy experience, we would like to ask you to observe some good RV camping practices. Please notify **PARKING OPERATIONS 263-3286** and inform us of any conditions requiring immediate attention.

NO REFUNDS AFTER AUGUST 12TH, 2008.

- Speed limit in RV areas is 5 MPH.
- Please keep RV space clean. No storage is permitted under or around RVs. **ALL VEHICLES MUST FIT INTO YOUR SPACE.** Parking in empty hook-up spaces, in fire lanes, or in visitor parking is not permitted. Illegally parked vehicles may be cited and/or towed. All RV's must stay in assigned space. RV and vehicle credentials are to be displayed on your windshield.
- Children must be supervised by an adult at all times.
- Clothes-lines are not permitted. Wind break with management approval.
- No recreational use of skate boards, bicycles, motor bikes/scooters or roller skates.
- Pets must be on leash at all times. No pets in buildings. No pets on grass areas
Pets must be kept quiet and under control. No pets may be left unattended.

Thank you for cleaning up after your pet.

- **STATE and COUNTY LAWS REQUIRE:**
 - ✍ No open fires. Barbecue grills and camp stoves are O.K.
 - ✍ No draining of sink water onto camping area.
- Laundry facilities are available at the RV Park (end of the Cul de Sac at Ethan and Hurley Way) for RV patrons only. Please help us keep this area clean.
- Do not attempt to gain entry to events on the Fairgrounds except through regular admission gates or in performance of your duties if participating in the event.
- All vehicles in Lot 16 and the Ogden Pad must display credentials, including passenger vehicles. All vehicles **must have license plates and current registration.**
- The backstretch and Horseman's trailer park are for personnel licensed with the California Horse Racing Board only.
- Please help us conserve electricity by not leaving air conditioners on when your RV is empty. Some rv spaces are supported by temporary electrical hook ups and your electrical use affects the use of other rv'ers in your area.
